 - a. To appear in person, report to Room 100 **on or before** the 20th day. Court room check in is available between the hours of 8:00 a.m. and 11:15 a.m. and between 1:00 p.m. and 4:00 p.m. You must bring photo identification.
 - b. To appear by video conference, speak with a clerk at the Virtual Public Counter via Zoom on a device with audio and video capabilities. Using the camera or QR code reader on your device, scan this QR code or enter the meeting ID 160 5330 6751 in the Zoom application to enter the virtual waiting room.



Warning – If you fail to comply within 20 days from the date of this notice, the total amount due will be referred for collection.
